Prof. Cancio Meliá has taught and teaches postgraduate courses (in Spanish, German and English) on different subjects in European (Turkey, Germany, Italy, Ukraine, Spain), Latin American (México, El Salvador, Venezuela, Ecuador, Brasil, Perú, Bolivia, Chile, Argentina, Uruguay) and Chinese (CUPL) Universities. He held the Gianformaggio visiting professor chair of the Università degli Studi di Ferrara in 2021 and was Stars-Program visiting professor at the Università di Bergamo in 2022.

Among his works, monographs on victim's behaviour relevance in criminal law (which was his doctoral thesis, *Conducta de la víctima e imputación objetiva*, 1998, 2nd ed. 2001), on causation (*Lineas básicas de la teoría de la imputación objetiva*, 2001), on terrorism offenses (*Los delitos de terrorismo: estructura típica e injusto*, 2010; coeditor of *Precursor Offences of Terrorism*, forthcoming Elgar 2022, with C. Walker and M. Llobet), on speech offenses (*¿Discurso de odio y/o discurso terrorista? Música, guiñoles y redes sociales frente al artículo 578 del Código Penal*, 2019, together with J. Díaz) and on the so-called "enemy criminal law" (*Derecho penal del enemigo*, 2003, 2nd ed. 2006, with G. Jakobs; coeditor of *Derecho Penal del enemigo. El discurso de la exclusion*, 2 vol., 2006, with C. Gómez-Jara), and his participation in several commentaries to the Spanish penal code are to be highlighted.

Other publications (books, chapters, articles, case discussions), regarding Criminal Law principles, Criminal Law legal dogmatics, compared Criminal Law studies, European Criminal Law and several single offences (sexual crimes, terrorism, personal injuries, crimes against the environment, organised crime), have been published in Spain, most countries of Latin America, Germany, the United States, Italy, Portugal, Great Britain, Belgium, Finland, Turkey, Taiwan, China and Ukraine.
