In 2000 I successfully finished my **PhD in Law at the Universidad Autónoma de Madrid**. Two years later, I moved to the **European University Institute**, in Florence, Italy, for a postdoc, with a grant of the Spanish Ministerio de Educación y Ciencia. In 2005 I obtained a



Ramón y Cajal contract in a competitive call. Shortly after, in 2007 I got national qualification (habilitación a profesora titular) and in 2009 I gained access to a permanent post at the **Universidad Autónoma de Madrid (profesora titular de Filosofía del Derecho)**. I have been **visiting fellow** at many national and international universities, including the **University of Oxford** (1996-1997), **Università di Genova** (1998), **Universidad Pompeu Fabra** (2003) and the **University of Sussex** (2018). In 2022 I got national qualification as full professor (**acreditación a catedrática de universidad**). My research includes issues on **personal autonomy; vulnerability; social rights and poverty; private and family life; women's human rights** and feminist theory; conflicts of fundamental rights; multiculturalism and **human rights**. **Publications** include articles in high Impact Factor international journals (Social and Legal Studies; European Journal of Women Studies; Ratio Juris; Revus) as well as Spanish and Latinamerican journals (Doxa; Isegoría; Análisis Filosófico; Isonomía; Cuadernos electrónicos de Filosofía del Derecho; Anuario de Filosofía del Derecho). I have been researcher at many **projects** with groups of various universities (6 projects as member of the Universidad Autónoma de Madrid legal philosophy group; 1 project with Universidad de Castilla-La Mancha legal philosophy group; 1 project with the UAM Women's Studies Institute group; 1 project with Universidad Carlos III political theory and international public law group); **I have been chief researcher (IP)** of a project UAM-Santander on Emerging Human Rights in Europe and Latin America: protection against gender violence, legal and case law strategies (CEAL-AL 2017-02). In occasion of the UAM-Santander project I coordinated 4 regional groups for Spain, Argentina, Chile and Colombia, and organized 2 international congresses and 2 publications (books in Didot and Aranzadi). Related to diverse of these projects, it is worth mentioning further publications on **emerging human rights** (chapter of a book by A. Ródenas, *Repensar los Derechos Humanos*, Palestra, 2018), **personal autonomy** (book *La autonomía de las personas. Una capacidad relacional*, CEPC, Madrid, 2018), and **private and family life** (*La protección de la vida privada y familiar*, Marcial Pons, 2021). Personal and relational autonomy have been at the core of my research in the last years, as well as associated issues, such as **vulnerability, vulnerable persons, social rights and poverty**. Together with research, **teaching** has also been intense and varied, including courses on Legal theory, Philosophy of law, Legal reasoning, Human rights and Gender studies. I have directed 2 PhD theses in the past and at the moment I am the director of 3 and codirector of 1 PhD theses. Regarding **University management**, I had positions of responsibility as deputy director and temporarily Director of Department (subdirectora y directora en funciones del Departamento de Derecho Público y Filosofía Jurídica), and Vice Dean of Institutional Relations (Vicedecana de Relaciones Institucionales y Prácticas). I have also developed an intense work as expert evaluator of research projects for the European Commission (Erasmus + KA3; Sixth Framework Programme; Horizon2020), as well as evaluator for national and regional Agencies (ACCUA, ANECA, and others); I have **translated many articles and books** included *Interpretar y argumentar*, R. Guastini, CEPC, 2nd edition, 2018.
